



Admission Policy and Enrollment Application

Our program is designed to provide students with a pathway to earning a high school diploma and an Associate's Degree in four years, with a focus on students who might not otherwise attend a college or university. JECA is not a private school or magnet school. We are a public high school in Judson ISD that is free of charge to our students and their families. All instructional materials for JECA students, including college textbooks, are paid for by JISD.

Our students follow a prescribed degree plan, which identifies the courses that students will take each semester. Beginning with the first semester of the 9th grade year, students begin taking college classes and earning college credit. Freshmen take two college courses their first year. Sophomores take four college courses. Juniors take six college courses, and Seniors take eight college courses. At the end of the four years, students can earn up to 60 college credit hours leading to an Associate's Degree in Liberal Arts. Because of the numerous college hours that they earn, most of our students are able to transfer into universities as Juniors, rather than college Freshmen, thereby saving themselves two years of schooling and tuition costs.

We hope your child will consider applying. JISD generally opens the application window in early December and closes the application window in late-January. If your child is currently in 8th grade, then your child is eligible to apply. These are the only criteria to apply. As an Early College High School, we do not consider applicants' grades, test scores, attendance, or discipline for admission to JECA.
