### **Summary Notes**

- 2.) Rosena requested completion of MOU by December 2017. Cabinet to meet September 7, 2017 12:30pm-4:30pm for internal review of the MOUs. Those unable to make this session will review MOU prior to 9/7 and send questions/comments to Anetia to be discussed during meeting.
- 3.) JECA Teachers inquired about shifting classes from junior year (ENGL, HIST, PHIL, PSYC) to sophomore year. Students must be college ready (TSI Complete) by end of fall semester of 10<sup>th</sup> grade.
- 4.) In the past, students have had assistance in submitting their ApplyTexas applications. It was suggested to bring students in again for assistance. Fifty-seven students attended last ApplyTexas Saturday session.
- 5.) The JECA student contracts were briefly reviewed and suggestions provided for updated contracts.
- 6.) JECA received 7 of 7 distinctions on performance report and ranked 1st in all 4 indices.
- 7.) STAAR testing dates are 5/7-5/10/18. 9th grade BIOL 5/7, 9th grade Algebra 5/8 and 11th grade HIST 5/8. These dates are the same dates as NLC Spring 2018 final exams. Also, it was mentioned that JECA students will take SAT test on October 11.

8.) There were 6 students who had registration/application issues. These students were attending class and chairs/faculty were aware of the "paperwork" issue. EDUC courses have been full for a few weeks but potential that BCIS may have available seats for these students.
